

# **Upper Uwchlan Township Emergency Management Planning Commission**

Thursday, January 25, 2018  
6:30 PM**

## **I     Call to Order**

Byron discussed the Business Continuity initiative and spoke to multiple local business owners and he said they were not interested. Byron mentioned it would possibly be beneficial to put something in the Spring newsletter to see if we could spark interest.

- B. Scott turned the meeting over to John DeMarco to discuss the upcoming large venue event happening in West Vincent Township on August 24, 25 and August 26. Country Music Festival and Concert. The concert is expecting approximately 15,000 people each day and the festival another 3 or 4 thousand people. This will impact our township tremendously with concentration on high volume traffic. He is working on an incident plan and should be done by June. Tony P said it would be an excellent opportunity to have all of our residents sign up for READY NOTIFY. He mentioned putting that in our Spring Newsletter.
