## Upper Uwchlan Township Building:

### Renovation and Addition

The Upper Uwchlan Township municipal building, located at 140 Pottstown Pike in the Village of Eagle, houses the township administration offices and the Police Department. The building has been expanded 2 times; first in 1987 when the original addition was made to the historic schoolhouse, and again in 1998. A new expansion of the building is now planned for 2019.

Residential and commercial growth in the Township has accelerated in recent years. The population of the Township is expected to reach 12,179 by 2020. As our Township has grown, so too have the staff and services of the Township administration and police department. The Board of Supervisors contracted with Hammel Associates Architects, LLC in 2018 to design an expansion of the Township Building at 140 Pottstown Pike. The goal of the expansion is to accommodate both current staff and expected future expansion of staff and services.

The design adds 2,697 square feet of office space to the upper level administration offices and 3,377 square feet of space to the Police Department on the lower level. The historic schoolhouse, where public meetings are held, will not be altered or expanded. The Board anticipates construction to begin in the spring of this year.

### Temporary Relocation

During construction, the Upper Uwchlan Township administrative office and Police Department will both be relocating.

### FAQs

**Can I still call the Township office?** Yes, the telephone numbers will remain the same.

**Where will public meetings be held?** Unless otherwise advertised, public meetings will be at the Administration office, 415 Eagleview Blvd., Suite 116, Exton, PA 19341.

**Where should I mail my sewer/trash payment?** The mailing address for payments will stay the same: P.O. Box 437, Uwchland, PA 19480. Bills may be paid in person at the 415 Eagleview address. OR pay online! Visit [upperuwchlan-pa.gov](http://upperuwchlan-pa.gov) and click the online payment button on the home page.

**Will there still be a payment drop box?** Yes! There will be a payment box at the relocated administration office, at 415 Eagleview Blvd., and at the relocated Police Department at 520 Milford Road (the southwest corner of Milford and Little Conestoga.)

**Can I still drop unneeded prescriptions at the Police Department?** No, the medication return program will be suspended while the Police department is in the temporary location. Nearby West Vincent Township has a medication take back box at the Police Department, located at 729 St. Matthews Road.

**How long will the offices be in the temporary locations?** The renovations to the Township building are expected to take about 12-16 months.

## EAGLE CROSSROADS

Last year, construction began on the newest municipal park in Upper Uwchlan Township. The new plaza, located in the Village of Eagle, was unveiled at the 2018 Block Party. Members of the public were invited to submit suggested names for the park. Thanks to all those who submitted their suggestions!

The Park and Recreation Board and Board of Supervisors are pleased to announce the selected name: **Eagle Crossroads!**

"The name says it all!" said Cathy Tomlinson, chair of the Upper Uwchlan Township Park and Recreation Board. "We envision Eagle Crossroads as a starting point or a resting spot for those exploring our ever-developing trail system." From the new plaza, pedestrian and multiuse trails lead residents to Hickory Park, Upland Farms, and, when the latest trail extension is completed, Marsh Creek State Park.

As business activity in the Village continues to grow, Eagle Crossroads will serve as a welcome rest area for those visiting the Village of Eagle to eat, shop, or play.

### What's still to come?

Additions and improvements are slated for the new park in the coming months: Frost free equipment will be installed for the water fountain, and the center seating feature will be stained. The veterans' memorial currently located in front of the Township building will be relocated to the park, along with the flag pole. Additional landscaping, curbing, and a sidewalk along the east side of Pottstown Pike will be installed as part of the Township building construction project.

# Recycle Right!

## Curbside Single Stream Recycling

Toss these items directly into your Recycling Toter. **DO NOT** use plastic bags.

**PAPER** Newspapers, cardboard, paper bags, magazines and junk mail, phone books, home/office paper, paper egg cartons, rinsed milk and juice cartons, clean pizza boxes, and boxboard food packaging. Break down and flatten.



**PLASTIC** Containers marked #1—#5 and #7. Throw away caps and lids. Rinse thoroughly.



**METAL** Food and drink cans, pie plates, clean aluminum foil. Rinse thoroughly. Empty aerosol cans.



**GLASS** Clean food and drink bottles and jars. Throw away lids. Rinse thoroughly.



### For the Garbage Toter



**TRASH** Food waste; light bulbs; mirrors, plate glass, window glass, drinkware and crystal; ceramic cups and plates, flower pots, ovenware; caps/lids from recyclable containers; empty paint cans, empty oil cans and bottles; plastic food wrappers, plastic bags; wax or plastic coated boxes/paper, plastic and Tyvek envelopes; straws, tissues, towels, napkins, plasticware; Styrofoam/polystyrene; shoes and clothing; metallic wrapping paper.

## Compost Leaves and Yard Waste: 36 Collections Annually - Wednesdays

Place leaves, grass clippings and yard waste in biodegradable paper bags or open containers. **DO NOT** use UUT Toters. **DO NOT** use plastic bags; these collections are composted. **DO NOT** overload bags. Tree limbs (no larger than 3" diameter and 3' long) must be bundled with string/twine. Place yard waste at the curb the night before collection to ensure it will be picked up.

## Trash & Recycling

UUT Toters are your **PRIMARY** containers for trash and recycling collection. Place Toters at the curb the night before your collection day, and at least 3 feet apart and away from mailboxes, cars and other obstacles.



Bulk pick-up is the 3rd pick-up of the month.

**DO NOT PUT CLEAN RECYCLING INTO PLASTIC BAGS – THEY ARE NOT RECYCLABLE!**

Recycling is to be put directly into the recycling toter, **UNBAGGED**. If you put in plastic bags, it does not go into the single stream recycling, it's contaminated and goes to **TRASH**, **DEFEATING** the purpose of recycling and not helping the environment. Styrofoam is not recyclable.

**SEE Chart for proper handling of recycling!**

Do you have only the (1) 64 gallon recycling Toter originally issued by the Township? Do you need additional recycling capacity? In an effort to emphasize single stream recycling and make it as convenient as possible, the Township will either swap your 64 gallon recycling Toter with a new 96 gallon recycling Toter or issue you an additional recycling Toter, all at no additional cost to you. If you are interested in additional recycling capacity, call 610-827-6033 to discuss your options.

**All recyclables are to be placed directly into the recycling toter.**



### Recyclable materials include:

aluminum products, glass, plastic, cardboard, newspaper, magazines, periodicals, bulk mail, phone books.

**Reminder:** The Township is no longer legally allowed to collect e-waste such as televisions, computers, etc.

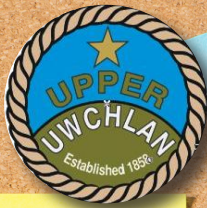
**Please note:** Yard waste is not considered trash and should **NOT** be put in with your trash. Use open containers (**NO** Attached lids) or brown compost bags. If yard waste is put in trash toter, it will not be taken.

**The burning of recyclable materials, to include yard waste, trees, shrubs, leaves, garbage, etc. is strictly prohibited. Burning permits are no longer issued.**

## Driver Alert! Wheels MUST be Covered by Fenders

Vehicles are prohibited from having their tires too far past the fender line of their vehicle. Vehicles must have the wheel covered at all times by the fender.

**Officers can issue one citation or up to four for each identifying uncovered wheel.**

Vehicle owners can remedy this by installing inexpensive fender flares to fully cover the wheel. Uncovered tires often throw debris and cause damage to other vehicles and pedestrians.

# Utility Billing Questions - ANSWERED!

Most residents of Upper Uwchlan Township will receive bills for sewer and trash/recycling from the Township.

## When are payments due?

Trash and Recycling is billed annually at a rate of \$315.00. You will receive only one bill each year in late January. You may pay a discounted rate of \$308.70 if you pay by March 31. Payment is due by September 30, after which a late fee will be applied.

Sewer is billed quarterly at a rate of \$190.00 per quarter. You may pay ahead. A 10% penalty will be applied to the balance of the account for late sewer payments.

Quarter 2	Mailed in April, Due by <b>May 31</b>
Quarter 3	Mailed in July, Due by <b>August 31</b>
Quarter 4	Mailed in October, Due by <b>November 30</b>

## Where can I pay my bill?

**Online:** Visit [www.upperuwchlan-pa.gov/payonline](http://www.upperuwchlan-pa.gov/payonline). Locate your account number and pin on your utility bill under "Account Information." The online module accepts ACH / E-Check payments as well as all major credit cards, with the exception of Visa Credit. All debit cards are accepted. Processing fees will be applied to online payments.

**In Person:** Drop your payment in the payment drop box at one of the Township's temporary offices. The administration temporary office is at 415 Eagleview Boulevard, Suite 116. The Police Department temporary office is at 520 Milford Road.

**By Mail:** Send to Upper Uwchlan Township, PO Box 437, Uwchland, PA 19480.

**Bank Auto-Pay:** You may set up automatic payments through your bank. If you do so, please ensure that the bank is provided with the correct payee information. Automatic payments should be made 15 days in advance of the payment due date to guarantee on-time postal delivery.

## Can I pay for both trash and sewer with one check?

No. Your sewer and trash account numbers are the same, but the bills must be paid separately. Please review your bills carefully.

## Payee Information:

Checks for trash/recycling should be made payable to Upper Uwchlan Township. Checks for sewer should be made payable to Upper Uwchlan Township Municipal Authority or "UUTMA."

## Can you waive my late fee?

No. Unfortunately, we cannot waive any late fees for payments. To be considered on time, payments must be received or postmarked by the due date. If you expect to be away when a payment is due, you are welcome to pay ahead.

## What if I mistakenly make a double payment?

Any overpayments will be credited to your account for the following bill or quarter. Refunds are not issued.

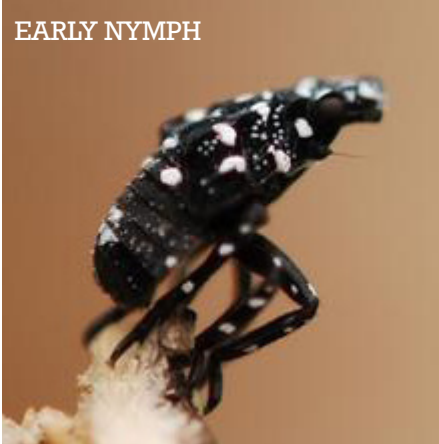
